# Getting Started Guide



# Overview

---

The Prox'N'Roll HSP PC/SC is a user-friendly contactless (NFC/RFID @13.56MHz) coupling device. This document will guide you through installing the proper driver and exploring the available software for a successful start using your Prox'N'Roll HSP PC/SC.

### - Important warning

The Prox'N'Roll HSP PC/SC uses a magnetic field to remotely power the contactless cards, and communicate with them. Magnetic waves are distorted or absorbed by conductive materials, including metal surfaces or shells. Also, the NFC/RFID communication is likely to be perturbed by other radiating devices (such as displays, radio or wireless communication interfaces) in the nearby. Place the Prox'N'Roll HSP PC/SC far from all sources of perturbations.

## Before you begin

---

SpringCard aims at making contactless devices simple to use. Even so you will win time by reading this guide before plugging the device to your computer.

# Download and install the driver

---

A PC/SC coupler requires a driver to operate.

## ☐ Microsoft Windows

If your computer is directly connected to the Internet, you may just plug the coupler and let the system download the driver Windows Update. Use the manual installation procedure below for computers that are not using Windows Update, or for a faster installation.

The **Prox'N'Roll HSP PC/SC** share the same driver (part number SD16055) as all other **SpringCard** USB PC/SC Couplers.

Launch the downloaded setup file to install the driver (you then need the administrative privileges on the computer).

Tip for network administrators: the driver setup could run unattended with the /SILENT command line flag.

## ☐ Linux and other UNIX

The **Prox'N'Roll HSP PC/SC** is fully supported by the PCSC-Lite open source project, through its USB CCID driver sub-project.

## The PC/SC QuickStart

---

### □ Microsoft Windows

The **PC/SC QuickStart** is a set of simple applications to test that the coupler and its driver have been correctly installed. They are also a good starting point to explore the world of contactless smartcards.

### □ Linux and other UNIX, □ macOS X

There are a few companion tools with the PCSC-Lite project that provide the same features as the PC/SC QuickStart for Windows:

- gScriptor

## Plug the coupler into a USB port

---

Plug the **Prox'N'Roll HSP PC/SC** into one of the computer's USB ports.

Wait 10 to 120 seconds until the operating system activates the driver and enables the coupling device.

□ Windows takes 10 to 120 seconds the first time you plug the coupling device into the computer only. Afterwards, the coupling device will be activated in a couple of seconds.

Keep an eye on the device: the **Prox'N'Roll HSP PC/SC** blinks yellow until it has been enabled by the computer.

As soon as the blue light enters a smooth “breath” sequence, the device is ready!

### - Precautions

As a contactless coupler, the **Prox'N'Roll HSP PC/SC** needs a clean power supply to remotely power the contactless cards, RFID labels or NFC tags. Do not try to operate the device through a non-powered USB hub nor through a passive USB cable extender.

## Verify that everything is OK

---

You need a (compliant) contactless card do pass this step. Use for instance a card from the NXP MIFARE family, or any NFC Forum Tag.

SpringCard also offers contactless cards. Need a small assortment of various chips to start your developments, or a large batch to issue many cards to your users? Just contact us:

### □ Microsoft Windows

Launch the **SpringCard PC/SC Diagnostic** application that has been installed by the **PC/SC QuickStart** package.

The application shows all the PC/SC couplers connected to the system. Verify that one of them is named *“SpringCard Prox’N’Roll Contactless”* (a number follows).

Place a compliant contactless card onto the **Prox’N’Roll HSP PC/SC**.

The device emits a **short beep** and illuminates **solid green**. The PC/SC Diagnostic application shows the card’s Answer to Reset string (ATR) on the coupler’s line.

Congratulations, your Prox’N’Roll HSP PC/SC is ready to work with!

### □ Linux and other UNIX, □ macOS X

Open a terminal and launch `pcsc_scan`.

The tool enumerates all the PC/SC couplers connected to the system. Verify that one of them is named *“SpringCard H663 00 00”* (the **Prox’N’Roll HSP PC/SC** is the very same core as the H663 module, and the open-source driver has no knowledge of the different form factor).

Place a compliant contactless card onto the **Prox’N’Roll HSP PC/SC**.

The device emits a **short beep** and illuminates **solid green**. `pcsc_scan` shows that a card has been inserted into the coupler, and explains the card’s Answer to Reset string (ATR).

Congratulations, your Prox’N’Roll HSP PC/SC is ready to work with!

## Understanding the LEDs & beeper

---

U.I. status	Description
“Breathing” blue	The device is ready, awaiting for a contactless card
Single beep+ Solid green	A contactless card is present and available for operation
Repeated beeps	The communication between the device and the card is not reliable. Move the card closer to the device. Install the device elsewhere.
Red, blinking	Malfunction (hardware error or overheating)
Yellow, blinking	The PC has not activated the device yet

## FAQ

---

### *The device does not light at all / The device keeps blinking yellow*

Verify that the driver has been correctly installed. Plug the device directly into one of the computer’s USB port and not through a hub or cable expender.

### *The Prox’N’Roll lights cyan, not blue – it is not listed by the OS as a PC/SC coupler but as a keyboard (Human Interface Device)*

Your device is a Prox’N’Roll RFID Scanner, not a Prox’N’Roll PC/SC. More details here:

### *The device has been correctly installed and appears in the Device Manager under the Smart Card class, but PC/SC Diagnostic does not show any coupler*

The PC/SC subsystem is disabled on your computer. Launch the “Services” applet in the Control Panel, and activate the “Smart Card Service” (ScardSvr.exe). More details here:

### *When I place a new card on the coupler, Windows tries to locate a driver and complains that a driver is missing*

Microsoft Windows now tries to associate a driver to virtually anything, including contactless cards, but only high-end cards providing digital signature services have such a driver. More details here:

### *The device does not 'see' my contactless card*

Verify that your card is in the compliance list (basically: compliant with ISO/IEC 14443-3 or ISO/IEC 15693-3 or a NFC Forum Tag).

Verify that this card technology is enabled in the configuration (see page 8).

Verify that your card is physically compliant with the coupler's RF field level and sensitivity (basically: card's antenna compliant with ISO/IEC 14443-1, card validated with ISO/IEC 10373-6 or -7).


# Going further – Device configuration

The Prox'N'Roll HSP PC/SC is highly configurable. Out-of-factory settings cover most of the use cases immediately, but advanced users may prefer to load a custom configuration into the device. For instance, it is possible to switch off the sound (beeper) or to disable some protocols, to silently ignore certain contactless cards.

To edit the configuration of the Prox'N'Roll HSP PC/SC, download and install MultiConf (part number SN14007):

MultiConf is available only on Microsoft Windows, but once the device has been configured, its settings are preserved when connecting to another operating system.



## Going further – Developers & integrators

---

PC/SC is an interoperability framework to develop smartcard-aware applications with no dependence between the application and the coupler (and driver), and with a standard API among Microsoft's and PCSC-Lite's implementations.

Therefore, there is no real specificities in developing with the **Prox'N'Roll HSP PC/SC**, and there are plenty of documentations, tutorials and even sample applications available on the web.

**SpringCard's** adds a stone to the building in the form of a free SDK featuring:

- A collection of reference utilities to explore all the functions of the MIFARE Classic, MIFARE Plus, MIFARE Desfire, MIFARE UltraLight C, ISO/IEC 15693 RFID labels including ICODE and TagIT, NFC Forum Tags, and more),
- A .NET wrapper that is portable among Windows and Mono, and a collection of examples in C#,
- The source code of most applications from the QuickStart.
